It is a song without noise or notes. It is a song of love beyond words, of faith beyond the power of human telling. I can hear it in my soul, when you awaken me to your presence. Amen.

Every Turn and Tune If there were anyone who knew about insecurity or a sense of not measuring up, it would be the thirteenth century theologian, Mechthild of Magdeburg: she wrote as a woman in a largely male-dominated world of letters. She did not know the more academic Latin of her time and instead wrote in her lay, mother tongue of German. As one of the wandering, marginalized and soon-to-beoutlawed "Beguine" mystics, she rejected the patriarchally prescribed routes for women in her time. Mechthild knew the heft and hurdle of change – as we too know the challenge when things go differently than anticipated. As Mechthild aged she was taken in by a nunnery after she lost her vision, receiving care after a life of giving care away to so many. Her call to alertness each morning is an animating voice that urges our eyes and ears open to God's presence at every turn and tune. Can you hear the voice of God even through the all the change?

Health and Wellness

Message from Director of Health Services Kacy Riley, RN



Dr. Latshaw, with Preferred Podiatry is coming to Cardinal View on Tuesday, September 13, from 9:00AM util 12:00PM. Dr. Latshaw will start in memory care and move to other areas of he building. If you have requested podiatry services in the past, you are on the list and only responsibility is to be available that day for services. If you are in need of services, please note that you do need to be in your apartment when Dr. Latshaw makes rounds. If interested a consent form needs to be signed. Please ask Kim at the front desk.

Rockmed Pharmacy will be having a flu clinic at Cardinal View in October. Please watch for more information. If you have an appointment and have an opportunity to receive your flu vaccine, please do so. Remember to update the community of any flu vaccinations received.

We have received a lot of questions regarding what qualifies residents for assisted living and how it is determined whether a resident may need a higher level of assisted living or memory care.

Our assisted living is licensed as a RCAC (Residential Care Apartment Complex) which allows us to provide up to four hours of care a day. Care provided must be scheduled and predictable to ensure adequate staff. Residents in our assisted living must be able to make their needs known, be able to utilize a pendant call light, and not require care that exceeds thirty-minute increments. In addition, residents would need to be alert and oriented, be able to pass a cognition assessment, free from complex co-morbidities or medical needs that are progressive and complex. Assisted living care is assistance that can be performed by a home health aide, not a registered nurse. Indicators of a higher-level care of residents include things as: frequent falls, medical intervention with frequent emergency department or hospitalizations, sliding scale insulin, wound care etc.

Memory care at Cardinal View is licensed as a CBRF (Community Based Residential Facility) which allows us to provide 24/7 care performed by home health aides. Qualifications for memory care our based-on community ability to met residents care needs as well as medical needs and our determined on an individual basis.

Administration Update

Message from Sr. Executive Director Julie Holden

All residents will be receiving a new "Residency Agreement" that will need to be signed and given back to Administration by October 1, 2022.

The new Residency Agreement includes the requirement of residents having Renter's Insurance for their home at Cardinal View by October 1st.

Specifically, we ask that this policy have minimum coverage of \$500,000.

Renter's Insurance: Resident agrees to obtain, maintain and keep in force for the duration of this Agreement



renter's insurance covering the replacement value of Resident's personal property. Resident understands that Community does not provide insurance coverage on Resident's personal property and understands that neither Community nor its insurance carrier will reimburse Resident for any loss of or damage to personal property unless the damage is caused exclusively by the negligent act or omission Community. The renter's insurance shall include a provision for general liability insurance covering bodily injury and property damage to others caused by the negligent acts or omissions of Resident, Resident's guests, invitees or visitors in an amount not less than \$500,000 per occurrence. The Tenant shall add the Community as an additional insured on a primary non-contributory basis. Prior to the Move-in date, Resident must provide Community with a copy of proof of renter's insurance.

Renters insurance protects personal property loss or damage, sometimes caused by water or fire, that are not covered by Cardinal View. Without renters insurance, residents may have to bear the financial burden of a loss to personal property.
